

AUTHORIZATION FOR AUTOMATIC PAYMENT

The authority you give to charge your account will remain in effect until you notify us in writing to terminate the authorization. If you would like to change the amount of your payments, contact us. If you change accounts or move, please contact us.

Keller Properties, Inc. will be transmitting all automatic payment requests on the fifth (5th) of each month. If the fifth (5th) falls on a weekend or a holiday, automatic payment will be transmitted on the next business day. This means that your bank will be deducting the payment from your checking on the 5th of each month.
