

## AUTHORIZATION FOR AUTOMATIC PAYMENT

We are pleased to offer homeowners an automatic payment option for payment of your monthly Association dues. You will not have to change your present banking relationship to take advantage of this service.

Here's how automatic payments work:

You authorize regularly scheduled payments to be made from your checking account, then sit back and relax! Your payments will be made automatically on the specified day and proof of payment will appear on your monthly bank statement.

Keller Properties, Inc. transmits all automatic payment requests on the fifth (5<sup>th</sup>) of each month. If the fifth (5<sup>th</sup>) falls on a weekend or a holiday, automatic payment will be transmitted on the following business day. This means that your bank will be deducting the payment from your checking or savings account on the 5<sup>th</sup>, or next business day, of each month.

The authority you give to charge your account will remain in effect until you notify us to terminate the authorization. **To cancel the Automatic Payment Authorization, or would like to make a change, please contact Keller Properties, Inc. prior to the 25<sup>th</sup> of the month before payment is to be made.**
